Nominations must be postmarked by June 1st of the year to the CMEA President who acts as the Award for Music Advocacy Committee Chairperson. Individuals may initiate the nomination, but group participation and system-wide involvement in the nomination is encouraged.

**Qualifications:**

- Is an advocate for music education in the school or community
- Shows strong leadership in the community and good rapport with educators, administrators, and government representatives
- Candidate's efforts may have led to a financial commitment for music education by school systems, community, and government
- Candidate's efforts may have led to improvements in curriculum, budget, or enrollment in music programs

**Nomination applications:** In addition to this form, the application should include:

- Biographical information
- Nominator letter of support addressing contributions to music education related to the above qualifications
- Additional letters of support (at least two)
- Picture suitable for printing

**It may also include:**

Photographs; news clippings; letters of endorsement and/or narrative descriptions from area educators, parents, students, volunteers or community leaders; of the nominee's specific support, unique leadership, and creative contribution in the area of music education. These are not required, however will add to the credibility of the nomination.
